Purpose

In TAISIYA ZUBAREVA we process the data you provide for the following purposes:

Provision of services

We use your data to process each of the services you request from us, to respond to your requests for information and to perform the billing and accounting of the company and to comply with our legal obligations.

The data will be provided by you, the categories of data we will process will be: identification data (name and surname, NSS, NIF, full address, telephone, email, signature, bank details for the management of collection and goods and services received or supplied.

Marketing

Keep you informed about our promotions, news, events and other news that may be of interest to you.

The data will be provided by you, the categories of data that we will treat will be: identification data (name and surname and email).

Attention to people's rights

To attend to the requests of the interested parties in the exercise of the rights established in the General Data Protection Regulation.

Legitimate Basis for Processing and Retention Period

Execution of a Contract

Your data will be necessary for the contractual relationship, not providing this data means the impossibility of providing the requested service (manage product warranties, make purchases, respond to your requests for information, etc.).

In this case, the data will be kept for the duration of the contractual relationship.

Legal obligations

In TAISIYA ZUBAREVA we must comply with a number of legal obligations for which the processing of your data is necessary, for example the issuance of invoices or submission of taxes to the public administration or to meet the rights that you request us.

The data will be kept for the legally required periods.

Consent

In the event that we send you by email, sms or any other electronic means marketing material (promotions, news, etc.) we will have your consent.

The data will be kept as long as you do not ask us to unsubscribe.

We inform you that you will have the right to withdraw your consent at any time, without affecting the lawfulness of the processing based on the consent prior to your withdrawal.

Communication of your data

Your personal data may be accessed by entities related to TAISIYA ZUBAREVA called data processors, such as accounting and tax advisors, service providers, maintenance companies, etc.

We may also communicate your data to public administrations and agencies for the fulfillment of legal obligations (for example, to the Tax Agency, State Security Forces and Corps) or to manage the bonus of the training credits of the entity in which you work (State Foundation for Employment).

Rights.

You have the right to obtain confirmation as to whether TAISIYA ZUBAREVA is processing your personal data.

Therefore, you have the right to access your personal data, rectify inaccurate data or request its deletion when, among other reasons, the data is no longer necessary for the purposes for which it was collected.

In certain circumstances, you may request the limitation of the processing of your data, in which case we will only keep them for the exercise or defense of claims.

In other situations and for reasons related to your particular situation, you may object to the processing of your data. TAISIYA ZUBAREVA will stop processing the data, except for compelling legitimate reasons, or the exercise or defense of possible claims.

You also have the right to request data portability in a format directly readable by electronic means.
